ORDINANCE NO. 03-2018

AN ORDINANCE AMENDING
ORDINANCE NO. 1-14, PLEASANT TOWNSHIP
PARKING ORDINANCE

WHEREAS, Pleasant Township, Warren County, adopted Ordinance No. 1-14 on November 25, 2014, which Ordinance regulates parking in Pleasant Township; and

WHEREAS, the Supervisors of Pleasant Township deem it advisable and in the best interest of the Township to amend the Ordinance in the manner hereinafter set forth.

NOW, THEREFORE, the Supervisors of Pleasant Township do enact and ordain, and it is enacted and ordained for Pleasant Township, Warren County, Pennsylvania, as follows:

1. The current Section 1 of Ordinance No. 1-14 concerning prohibited parking in the Township, shall be deemed amended to add the following new sub-paragraph:

SECTION 1:

- I. In such a manner that it obstructs the view of the roadway from any adjoining property.
2. The current Section 2 of Ordinance No. 1-14 concerning enforcement, shall be deemed amended to read as follows:

SECTION 2:

Enforcement hereof shall be by an action before a District Justice in the same manner provided for enforcement of summary offenses. The Board of Supervisors hereby set a criminal fine in the amount of Fifty Dollars (\$50.00) per violation and the cost of prosecution, and, in default of payment of such fine and cost of prosecution, to undergo imprisonment of not more than thirty (30) days, provided, further, that each day's continuance of a violation shall constitute a separate offense. In addition, any vehicle in violation of this Ordinance may be authorized for removal by the

Supervisors of Pleasant Township, their employees or the Pennsylvania State Police, and the cost of such removal, together with court costs, may be recovered in a summary proceeding before a District Justice.

- 3. The current Section 3 of Ordinance No. 1-14 shall be renumbered as Section 4. Section 3 shall hereinafter be deemed to read as follows:

SECTION 3:


Any vehicle found to be in violation of this Ordinance may be authorized for removal and/or towing by the Supervisors of Pleasant Township, their designee, or the Pennsylvania State Police and the cost of such removal and/or towing, together with court costs, may be recovered in a summary proceeding before a Magisterial District Justice.

- 4. In all other respects, Pleasant Township Ordinance No. 1-14 shall remain unchanged.
